

Minutes of the Managing Committee of the pudukotti District Mineral Foundation Trust Meeting held on 20.09.2024 at 4.30 P.M under the Chairmanship of the District Collector, pudukottai.

The 5th Managing Committee Meeting of the pudukottai District Mineral Foundation Trust (DMFT) was held on 20.09.2024 at 4.30 P.M in the meeting Hall at Collectorate, pudukottai under the Chairmanship of the District Collector, pudukottai.

At the outset, the District Collector welcome all the participants present in the meeting. Thereafter, the District Collector reviewed overall financial position for the implementation of PMKKKY project.


The District Collector has informed the house that the very purpose of the meeting is to review the progress of actions taken by executing agencies and District Level Officers on various matters and activities as decided by the Governing Council Committee in its last meeting held on 18.07.2022 Also opined that important projects will be sanctioned on priority basis to start the works in the fields.

After detailed discussion and deliberation, the following important decisions were taken unanimously in the meeting.

1. An amount of Rs. 227.98 Lakhs has been sanctioned to purchase of equipment for Primary Health Center, at various block in Pudukottai District as per G.O.(D).No.19 Industries (MMD.1) Department Dated 09.02.2021.

2. An amount of Rs. 62.00 Lakhs has been sanctioned for procurement of steel desk and benches for school in various block for the projects approved in the last meeting date 08.01.2021.
3. An amount 118.17 Lakhs has been sanction for the Infrastructure development for the project sanction in the G.O.(D).No.19 Industries (MMD.1) Department Dated 09.02.2021.
4. The Block Development officer (VP) Annavasal has been directed to complete the project sanctioned vide G.O.(D).No.19 Industries (MMD.1) Department dated 09.02.2021 for construction of RCC slab culvert and retaining wall at valaiyanvayal road in Thiruvengaivasal panchayat of Annavasal block to the tune of 34.00 lakhs within the stipulated time.
5. The Executive Committee delegated the powers of according financial sanction and Administrative approval for the projects and release of funds immediately. (Action:- The Assistant Director, Geology and Mining,, Pudukottai).

The meeting ended with vote of thanks.







